

EU Disability Rights Strategy 2021-2030

The European Commission presented the new 10-year Disability Strategy in March 2021.

The strategy is divided in 8 areas. In each area, the Commission sets:

- Flagship initiatives;
- Other initiatives, such as guidance to Member States;
- **Calls to Member States** to implement actions in line with the UNCRPD and the disability strategy.

Inclusion Europe wanted to see an ambitious disability strategy with clear targets, fostering change with a concrete impact on the quality of life of people with intellectual disabilities and families, for instance:

- 1. Address the importance of the right to make decisions;
- 2. Establish clear targets to end segregation;
- 3. Address violence against women with intellectual disabilities;
- 4. Recognise the role of families in fulfilling rights and providing support to their relatives with disabilities;
- 5. Connect to peoples' experiences and be easier to understand.

With a particular attention throughout the strategy to:

- Children with intellectual disabilities and their families;
- Women with intellectual disabilities;
- People with complex support needs and their families.

We believe there are many areas where the EU can and should implement direct and profound change, for example:

- Employment of people with disabilities in EU services and agencies;
- Education (Erasmus programmes, European schools);
- Accessibility of information and procedures.

64.3% of persons with disabilities aged 16+ have an internet connection at home compared to **87.9%** of persons without disabilities

Decent quality of life and living independently



More than 1 million children and adults with disabilities aged less than 65 and more than 2 million aged 65 and over live in institutions



50.8% of persons with disabilities are in employment compared to **75%** without disabilities



37.6% of persons with disabilities are inactive compared to **17.6%** of persons without disabilities



28.4% of persons with disabilities are at risk of poverty and social exclusion compared to **18.4%** of persons without disabilities

It will be of critical importance to ensure people with intellectual disabilities and family members are properly involved and heard during the work on **independent living** guidance; people with intellectual disabilities and with complex support needs continue to be neglected in deinstitutionalisation efforts.

"Many persons with intellectual disabilities still depend on institutions, support services and parents. Self-advocates complain that support services and staff still have much control over them. They often do not respect self-advocates' opinions and wishes. This is because the old ways of thinking, common for institutions, are still present in support services."

Equal access and non-discrimination



52% of persons with disabilities feel discriminated against



4 times more persons with disabilities report unmet healthcare needs than those without disabilities



20.3% young people with disabilities leave school early compared to **9.8%** of those without disabilities



Only **29.4%** of persons with disabilities attain a tertiary degree compared to **43.8%** of those without disabilities

This area is important for several reasons.

First, to ensure the guarantee of these rights, **supported decision-making** is of essence.

- Key Elements of a System for Supported Decision-Making
- Safeguards in measures relating to the exercise of legal capacity

To ensure safety, protection and justice, **training of practitioners** on support needs of people with intellectual disabilities, and **education to their rights** of people with intellectual disabilities is fundamental. A particular attention should be paid to women with intellectual disabilities victims of violence, including structural violence.

For education, the progress towards **inclusive education** is welcome but no more EU funds should be invested towards segregated education.

Improving **healthcare** is urgent, and so is making sure it is available for people with intellectual disabilities.


